Mayor McKenna presided as Chairman of the meeting during the election of the President of Council and appointed Craig A. Robinson to serve as Temporary Secretary. The Chairman asked for nominations for the office of President of Borough Council. Mr. Jurewicz nominated Mr. Dworin. The Temporary Secretary was directed to take a Roll Call Vote for Mr. Dworin and the Roll Call Vote was as follows: McAbee – Yes, Law – Yes, Dworin – Yes, Jurewicz – Yes, Yankes – Yes, Collins – Yes, and Lepidi – No. Mr. Dworin was voted Council President by Majority Vote.

Mr. Dworin assumed his office as President of Council.

Nominations for the office of Vice President of Council were requested. Ms. Law nominated Mr. Jurewicz. Mr. Collins nominated Mr. Lepidi who declined the nomination.
